In exercise of the powers conferred upon me under sub-section (a) of section 8 of the Customs Act, 1962 (52 of 1962) I, S.L.Thakur, Commissioner, Central Excise, Bolpur, hereby approve the Inland Container Depot (in short ICD) located in Export Promotion Industrial Park, Durgapur, as a place for loading of export goods and unloading of imported goods subject to strict observance of all relevant provisions of the Customs Act'62, notifications, rules and regulations made there under and instructions issued by the Central Government and by the Commissioner of Central Excise, Bolpur from time to time.

In exercise of the powers conferred upon me under sub-section (b) of Section 8 of the Customs Act, 1962 (52 of 1962) I, hereby further specify the limits of Customs area comprising 23,575.39 square mtrs., falling under Mouza, Banskopa, J.L.No.61, P.S.Kanksa, Distt.Burdwan, Khatian No.218, C.S.Plot No.1(P)HAL-DAG, 762(P), 768(P),769(P),770(P),776(P),777(P),778(P),779(P), 780(P), 823(P),1556(P), 1557(P) of Durgapur, West Bengal, which is bound as under:-

1. On the North-East side – by a 171.60 mtr., long and 2.52 mtr. high brickwall boundary with 0.90 mtr. high barbed-wire fencing on top, adjoining 15 ft(4.5 mtr.) wide public road to its North.
2. On the North-West side-by a 134.450 mtr. Long and 2.52 mtr. High brickwall boundary with 0.90 mtr. high barbed-wire fencing on top ,with two entry gates & two exit gates on this side, adjoining 30 Ft(9 mtr) wide Public Road to its West.
3. On the South Eastern side-by a 132 mtr. long and 2.52 mtr. high brickwall boundary with 0.90mtr. high barbed-wire fencing on top, adjoining 15 Ft(4.5 mtr) wide Public Road to its East.
4. On the South West side-by a 136.40 mtr. long and 2.52 mtr. high brickwall boundary with 0.90 mtr. high barbed-wire fencing on top, adjoining 15 Ft(4.5mtr) wide Public Road to its South.
